#### **HISTORY**


- Created in 1946 by the United States Congress,
   Fulbright is the U.S. government's flagship international educational and cultural exchange program.
- Fulbright is sponsored by the U.S.
   Department of State with funding provided by the U.S. government.
- Since 1946, more than 400,000 Fulbrighters, representing 160 countries, have participated in the program.

# **Fulbright Specialist Program**

Established in 2001, the Fulbright Specialist Program is a part of the larger Fulbright Program that provides U.S. citizens who are well-established academics and professionals with opportunities to serve as expert consultants and engage in short-term, project-based exchanges at a range of institutions across the globe.

- 2-6 week projects focused on education, training, or capacity building
- 150+ eligible countries and other areas
- ~400 projects annually
- Specialist benefits include round-trip economy class international airfare, modest transit allowance, \$200 daily honorarium, visa fees, and limited benefits health plan. Host institutions traditionally provide lodging, meals, and in-country transportation.

# What Do Specialists Do?

- Delivering seminars, training or workshops
- Consulting on faculty or workforce development
- Developing academic or training curricula and materials
- Giving lectures at the graduate or undergraduate level
- Conducting needs assessments or evaluations for a program or institution
- Supporting accreditation process for a university program
- Engaging in strategic planning activities

## **Program Structure**

- Host-driven structure: overseas institutions develop and submit project proposals.
- U.S. individuals must apply for admission to the Fulbright Specialist Roster and be approved by peer review panel; application deadlines for the Roster are every two months.
- If admitted, Roster candidates receive a **threeyear tenure** during which they are eligible to be matched with a project.

#### **Key Eligibility Criteria**

- U.S. citizenship
- Demonstrate significant experience/expertise in their field
- Open to tenure-track and non-tenure track faculty, emerita/us faculty, administrators, and established professionals.
- U.S. Alumni of other Fulbright programs are eligible to apply with no waiting period
- For those on the Roster, a 24-month waiting period between Specialist projects and tenures applies



# **Application Components**

#### Required:

- Personal Information
- Education
- Employment
- Resume/CV
- Essays (2)
- References (3)

#### **Optional:**

- Geographic Preferences
- Language Skills

**Essay One:** Please describe why you are interested in serving as a Fulbright Specialist and how your participation would benefit a host institution abroad as well as your institution/ employer in the U.S.

Please include specific examples of activities that you may be interested in leading or completing at your host institution abroad as part of your program.

**Essay Two:** Please describe any previous experience working in an international environment and why you believe that you would be effective serving as a Fulbright Specialist at a host institution abroad.

If you do not have prior experience in an international setting, please describe what strategies you would employ in order to be successful while serving as a Fulbright Specialist in a cross-cultural context.



### What's Next? Identifying a Match

Once accepted to the Roster there are **two pathways to match** with an institution:

#### **Open Projects**

- View and apply to an ongoing list of available 'open' projects during your three-year tenure
- Host institution reviews a list of qualified candidates and selects a finalist
- Finalist candidate(s) hold follow up call with host institution to confirm match

#### **Named Projects**

- Institutions may nominate you as their preferred candidate when submitting their project proposal
- Roster candidates may be in contact with prospective hosts, but institutions must lead proposal development and submission
- Regardless of nomination, one must meet all eligibility criteria to serve as the Specialist
